- This MOU may renew upon its expiry with the agreement of both the parties.
- Each party may propose to the other amendments to this agreement in writing.
   Such amendments shall be established by mutual written agreement of the parties.
- This agreement or its renewal and the action taken under it may be received at
  any time. These modifications may be made by mutual agreement and any
  amendment or extension to the agreement may be formalized by the exchange of
  letters between two parties.
