There is no financial commitment on the part of the R. M. Khandala to up any programme mentioned in the M.O.U. if there is any financial consideration it will be dealt separately


Commencement, renewal, termination and amendment:

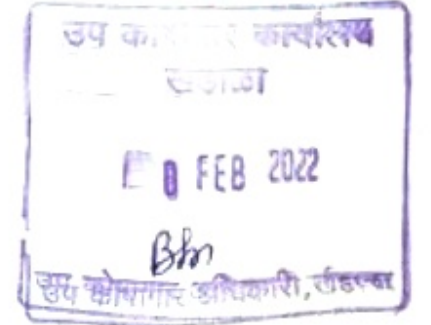
