## **Code of Conduct for Teachers**

- ${f 1.}\;$  A teacher should obey rules/orders/suggestions of University and College time to time
- 2. A teacher should act with honesty and integrity of their work.
- A teacher should teach in such a manner that respects the dignity and rights of all persons without prejudice of cast, creed, gender and religion.
- **4.** A teacher is responsible for analyzing needs, prescribing and carrying out educational programs with updated knowledge and high quality, and evaluating progress of students.
- **5.** A teacher may not delegate his or her responsibilities to any person who is not a teacher.
- **6.** A teacher does not engage in activities, such as private tuitions which adversely affect the qualities of professional ethics.
- 7. A teacher should integrate his teaching and learning with his or her research.

#### **Code of Conduct for Students**

- 1. Students should strictly follow dress code and carry identity cards in the campus.
- 2. Students should read notices daily displayed on board, sent by Google class room, mail or social media.
- All students shall must follow the rules and regulations of the College, and University time to time
- 4. A college working schedule from Monday to Saturday is followed excluding holidays.
- 5. The classes are scheduled in one shift for all streams. The students shall attend the national anthem and the classes punctually.
